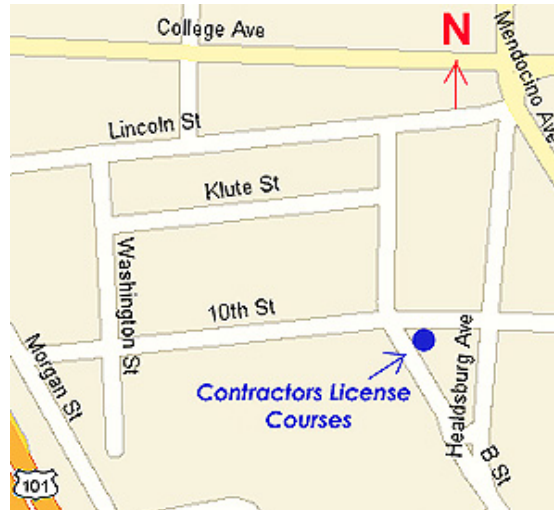
General Engineering – A

WHAT ARE THE REQUIREMENTS FOR A LICENSE?

If you have worked at least four of the last 10 years in a building trade – as a journeyman, foreman, supervisor, or self-employed tradesman – you may apply for a state contractor's license in that trade. Apprenticeship programs, technical training related to your trade, and college courses related to the construction business also count toward the four-year total.

To get your license, you need to submit an application to the Contractors State License Board (CSLB) and take two 2½-hour exams, one on law & business management, and the other on your trade. (For a supplemental classification, you need not take the law exam again, but only the exam for the supplemental trade.)

WHY GET A LICENSE?

- ♦ Legally **take on jobs over \$500** and **protect** yourself against lawsuits.
- ♦ **Advertise** as a licensed contractor in the Yellow Pages, newspapers & other media.
- ♦ **Bid** on state and local **government projects** and on projects financed by banks, S&Ls, and insurance companies.
- ♦ **Join builders' exchanges** and contractors' associations, which offer job lists and group insurance rates. You can get contractor's credit accounts and discounts from building suppliers.
- ♦ You **won't risk penalties**, prosecution, or nonpayment for contracting without a license. You will have mechanics lien, stop notice, and bond rights to make sure you get paid.
